Catholic Charities Legal Services, Archdiocese of Miami, Inc., also known as Catholic Legal Services, (hereafter "CLS"), is a nationally recognized agency with an experienced team of attorneys and immigration professionals. CCLS mission is to provide professional legal services, both application assistance and attorney representation before the Citizenship and Immigration Services, the Immigration Courts and the Board of Immigration Appeals, to those who come from foreign lands who lack sufficient means to obtain representation without regard to faith or national origin. In addition to its professional competencies, Catholic Legal Services' staff reflects the diversity of the population it serves, allowing for culturally sensitive and linguistically appropriate services. Our clients come from all paths of life. We serve people from 185 countries and territories.

OUR MISSION

- Legal representation and immigration services to those who come to South Florida from foreign lands;
- · Professional assistance to those who lack sufficient means to obtain legal help; and
- Quality services without regard to faith, race, national origin, or any other distinguishing characteristic.

OUR HISTORY

Catholic Legal Services grew out of the G.W.L. Legal Project, established in 1994 at Notre Dame D'Haiti Pierre Toussaint Center to provide legal services and immigration representation to refugees and immigrants from Haiti. The project rapidly expanded beyond the Haitian community because of the vast immigrant community in South Florida. Incorporated on January 8, 1998, when the G.W.L. Legal Project (1994) merged with the Catholic Legal Immigration Network in Miami (1988), CLS has become one of the most active nonprofit providers of legal immigration services in Florida.

From 3 staff to 69 staff including 31 attorneys and 5 DOJ-accredited representatives [A DOJ-AR is a person who is approved by the Department of Justice to represent aliens before the Department of Homeland Security (DHS) and the Executive Office for Immigration Review (EOIR), which includes the immigration courts and the Board of Immigration Appeals (BIA), and must maintain a high standard of professional conduct] with two locations in Miami-Dade and Broward Counties, CLS has served refugees and immigrants from around the world. Most CLS clients come from across the Americas, and CLS staff reflect their diversity of language and culture.

More than two thousand individuals seek the services of CLS each month including immigrants seeking to reunite with their families, many of whom were separated at the border; political and religious refugees seeking safety and security, many of whom have experienced persecution and torture; battered spouses and their children; religious workers seeking to minister to U.S. religious communities; and long-term residents of the United States with significant family and community ties who face deportation. These services include representation before the Immigration Court (IC), Board of Immigration Appeals (BIA), United States Citizenship and Immigration Services (USCIS), United States Immigration & Customs Enforcement (ICE) and Juvenile Court (JC).

These individuals, ranging from 2 months to 104 years of age, confront a complex immigration law system and a confusing bureaucracy. Many have unhealed wounds from a painful past and then encounter unexpected bigotry and barriers as they adjust to a new culture and way of life. They often face an uncertain future. However, with CLS help, many deserving immigrants and refugees persevere and realize their dreams for a bright and secure future in the United States.



Daniella Levine Cava was elected Miami-Dade County's first-ever woman Mayor in November 2020. She enters the Mayor's office following a nearly 40-year career as a relentless advocate for South Florida families in public service and elected leadership.

As Miami-Dade County's Mayor, she oversees a metropolitan government with nearly 30,000 employees serving nearly 3 million residents, managing an annual budget of approximately \$10 billion.

A social worker, lawyer, and community activist, she was first elected in 2014, and re-elected in August 2018, to serve as the Miami-Dade County Commissioner representing District 8.



Archdiocese of Miami

The Archdiocese of Miami is home to over half a million Catholics in Miami-Dade, Broward and Monroe Counties. Mass is celebrated in 17 languages. We have 108 churches and missions plus the National Shrine of Our Lady of Charity; and 63 schools, including 14 high schools. The archdiocese is led by Archbishop Thomas Wenski.

JULIE GRIMES

MANAGING PARTNER, HILTON BENTLEY HOTEL

Julie Grimes is a dynamic leader with a distinguished career in the hospitality and real estate industries. As the Managing Partner of the Hilton Bentley Hotel in Miami, FL, she drives strategic direction and operations. She also holds the role of Executive Director at Heafey-Bentley Management, contributing to real estate and hotel development achievements.

In 2007, Grimes co-founded the Hospitality Institute in Overtown, training over 1,000 inner city residents for local hospitality roles. She collaborated with Miami Dade College to establish the institute, fostering sustainability.

Following the 2008 hurricanes in Haiti, Mayor Manuel Diaz appointed Grimes Chairperson of Operation Hope for Haiti, raising substantial funds for World Vision's impactful interventions.

Grimes co-founded the Center of Service Excellence at Miami Dade College in 2008, elevating customer service standards in South Florida. Her commitment to education led to partnerships with Big Brothers & Big Sisters and Take Stock in Children, supporting at-risk students.

As Chair of Miami Dade College Foundation and a Camillus House Board Member, Grimes remains dedicated to community welfare. Her notable accolades include Tourism Profession of the Year nomination and the James W. McLamore Outstanding Volunteer of the Year Award.

Originally from Canada, Grimes began in Public Works Canada, later venturing into the private sector. She holds a Business Administration degree from Algonquin College, and her move to Miami in 1995 marked the launch of the Doubletree Grand Hotel. Grimes became a US Citizen in 2004.

VANESSA JOSEPH, ESQ.

IMMIGRATION ATTORNEY, CATHOLIC LEGAL SERVICES, INC. ELECTED CITY CLERK, CITY OF NORTH MIAMI

Vanessa Joseph is an immigration attorney based in Miami, Florida. She began her work in immigration and human rights as a law student when she worked in two legal clinics where she was able to engage in advocacy on behalf of the Haitian community of South Florida. In 2013, Joseph contributed to an *amicus curiae* brief filed in the case of *Benito Tide Méndez et al. v. Dominican Republic* before the Inter-American Court of Human Rights. This brief focused on human rights violations by the Dominican Republic in its process of carrying out mass deportations of Haitians and Dominicans of Haitian descent without allowing them proper due process or taking into account humanitarian considerations. At that time, at the grassroots level, Vanessa also helped the local Haitian activists of *Fanm Ayisyen Nan Miami* (FANM) organize a rally to protest the Dominican government's actions and decision.

Vanessa also worked with the Miami Law Health Rights Clinic where she represented dozens of low-income individuals who struggled with mental health issues, were HIV+, or had AIDS. During this time, Vanessa was an Equal Justice Works AmeriCorps JD Fellow, where she delivered critically needed legal assistance to veterans in low-income and underserved communities in South Florida. Her hard work and dedication in the Health Rights Clinic led her to earn the CALI Excellence for the Future Award in the summer of 2014.

Today, as a Supervising Attorney at Catholic Legal Services, continues providing legal services to vulnerable populations. In addition to representing low-income immigrants, Vanessa conducts information sessions for immigrant detainees to inform them of their rights and the immigration court process. Through her work in the detention centers, she has provided these services to more than one thousand men and women through group and individual orientations and self-help workshops. Vanessa currently leads collaboratives dedicated to providing immigration resources and education to vulnerable populations across South Florida.

As a member of the South Florida chapter of the American Immigration Lawyers Association (AILA), Vanessa serves as a Chair of the State Issues Committee and a member on the Pro Bono and Office of Principal Legal Advisor (OPLA) committees. As member of AILA, Vanessa is focused on helping South Florida's immigrant community find and secure competent legal representation and advocating on the issues that affect the immigrant communities in South Florida. Vanessa also serves as the Secretary for both the Haitian Lawyers Association (HLA) and the Haitian American Professionals Coalition (HAPC). Vanessa recently joined the board of FANM where she helps the organization continue its critical work of empowering Haitian women and their families, and the board of Casa Valentina where she supports the organization's mission of helping youth transition successfully from foster care to independent living.

In addition to being an attorney, Vanessa is a public relations and marketing professional who has helped brands and companies connect with Haitian consumers.

As the daughter of Haitian immigrants who moved to the United States in the late 1980s, her dedication to the Haitian community of Florida is unwavering. These are the driving forces of Vanessa as a professional: a desire to serve as an advocate for marginalized communities such as the immigrant population and people with developmental disabilities; and, a dedication to the promotion of culture and creativity, especially her own Haitian heritage. Vanessa's strong beliefs in every individual's right to proper legal representation and the agency to fully participate in decision-making that affect their own lives inform every professional decision she makes. With a Juris Doctor from the University of Miami and a Master in Public Administration, Vanessa is and will continue to be a purposeful and passionate agent for change.

Given her passion for service, Vanessa Joseph, in 2019, was elected as the City of North Miami's Elected City Clerk. In this office, she makes history as both the City's youngest and first Black female City Clerk. While in office, Vanessa has worked to increase civic engagement amongst North Miami residents through various initiatives, including voting campaigns and the Madam Clerk Project, a civic education initiative targeting children. In December 2022, Vanessa earned the professional designation of Certified Municipal Clerk, becoming the first elected City Clerk of North Miami to earn such a designation.

EXECUTIVE DIRECTOR, AMERICAN BUSINESS IMMIGRATION COALITION (ABIC)

Rebecca Shi is the visionary founder and executive director of the American Business Immigration Coalition (ABIC). This bipartisan coalition comprises over 1200 influential figures, including CEOs, retired CEOs, donors, employers, and business associations from coast to coast, spanning states from Texas to Maine, Florida to Idaho. ABIC is dedicated to advancing common-sense immigration reform, promoting economic growth, job creation, and family unity. Notably, ABIC strategically lends business support to impactful national, state, and local campaigns that champion the rights of undocumented individuals. Recognizing the power of cross-partisan collaborations, ABIC secures tangible victories through alliances that bridge political divides. These accomplishments range from securing essential rights like driver's licenses, in-state tuition, healthcare equity, and access to justice across a spectrum of states, including red, purple, and blue.

Rebecca's personal journey as an immigrant from China at the age of ten fuels her deep commitment to the cause. She graduated with high honors from the University of Chicago, where she also delivered the commencement speech. Fluent in English, Mandarin, and Spanish, she possesses a strong multicultural perspective. Over the course of 12 years, she has emerged as a dynamic leader and organizer within the immigrant rights movement. Her mother's 19-year-long struggle with a deportation order has further driven her dedication.

Rebecca's impactful contributions have been widely recognized. She was honored as one of "20 in their 20s" by Crain's Business Chicago, acknowledged for her Asian American community leadership, and named an Illinois Governor Jim Edgar Fellow. Her work has been featured in esteemed publications like the Wall Street Journal, Washington Post, New York Times, Texas Tribune, Miami Herald, Chicago Tribune, Politico, and Axios. She has also been a vocal advocate, testifying multiple times before the United States Congress.

RANDY MCGGORTY

EXECUTIVE DIRECTOR, CATHOLIC LEGAL SERVICES, INC.

Randy P. McGrorty is the Executive Director of Catholic Legal Services, Archdiocese of Miami (CLS), holding this role since the inception of the agency. He supervises a staff of 45, with 22 staff attorneys, serving nearly 3,000 clients monthly. These cases include individuals seeking to reunite with their families, political and religious refugees seeking safety and security, victims of domestic abuse, and long-term residents of the U.S. with family and community ties who face deportation. CLS has a strong bond with South Florida's Haitian Community as a primary provider of immigration services. This past year, CLS has spearheaded efforts to legally represent unaccompanied minors in removal proceedings. McGrorty graduated magna cum laude from Harvard, and earned his J.D. and M.S.S.W. from the University of Wisconsin. A frequent speaker on asylum and immigration related topics, he has been awarded the Adalsinda Lomangino Award and various other recognitions for contributions to immigration law and immigrant communities.

JACQUELINE CHARLES

CARIBBEAN CORRESPONDENT AT THE MIAMI HERALD

Jacqueline Charles is an accomplished foreign correspondent for the Miami Herald, renowned for her insightful coverage of Haiti and the English-speaking Caribbean. She recently received the 2023 ICFJ Excellence in International Reporting Award, adding to her impressive list of achievements.

Beginning her career as a high school intern at the Herald, Jacqueline's dedication and skill led her to become the go-to journalist for stories involving Haiti. Her extensive coverage earned her recognition as a Pulitzer Prize finalist and an Emmy Award winner. Notably, she was also honored with the Maria Moors Cabot Prize, one of international journalism's oldest accolades, for her exceptional reporting on the Americas.

Jacqueline's journalism journey started early, with her first overseas assignment covering the return of Haitian President Jean-Bertrand Aristide. Over the years, she has been at the forefront of major events, including Aristide's subsequent return and Haiti's historic 2011 presidential runoff.

Beyond her Haiti coverage, Jacqueline's versatility shines through her reporting on various topics. She has covered Miami's underserved communities, Broward County schools and government, the Florida Legislature, immigration, and social services. Her work has exposed issues such as school construction mismanagement and inequalities in education.

Born in the Turks and Caicos Islands with Haitian and Cuban-American roots, Jacqueline's unique background has fueled her passion for diverse communities. Her assignments have taken her across the Caribbean, covering subjects as varied as race in Cuba, whale hunting, and child trafficking.

Jacqueline's dedication to journalism and her impact on the field have been widely recognized. She is a founding member of the Carolina Association of Black Journalists and has served in leadership roles within the South Florida Association of Black Journalists. Her commitment to journalistic integrity and reporting excellence has earned her numerous awards, including the Journalist of the Year award from the National Association of Black Journalists for her coverage of Haiti's earthquake.

Her contributions extend beyond her reporting. Jacqueline co-produced a documentary on Haiti titled "Nou Bouke," which aired on PBS and earned her and her colleagues an Emmy Award. She was also part of the Miami Herald team that received a Pulitzer Prize for their Panama Papers investigation.

A social worker, lawyer, and community activist, she was first elected in 2014, and re-elected in August 2018, to serve as the Miami-Dade County Commissioner representing District 8. As Commissioner, she invested in Miami-Dade small businesses and expanded economic opportunity, protected the environment and our water, increased the County police force for underserved areas, advocated for an expanded, reliable public transportation system, worked to create affordable housing and revitalize neighborhoods, and helped make local government more accountable and transparent.

In the aftermath of Hurricane Andrew, she was recruited to create a new intake system for child abuse cases with the Department for Children and Families. Her efforts were concentrated on the neighborhoods of District 8 where she helped restore the lives and homes of those devastated by the storm.

In 1996, Mayor Levine Cava founded Catalyst Miami to help low- and middle-income families through service, education, and advocacy. Catalyst helps approximately 5,000 people each year to become more self-sufficient and civically engaged.

She is the Immediate Past Chair of the South Florida Regional Planning Council (SFRPC) and served as an SFRPC Council Member from 2015 – 2020. She has served on the Florida Bar Committee on Legal Needs of Children; the boards of League of Women Voters, Orange Bowl Foundation, North Dade Medical Foundation, South Florida Health Information Initiative, and several national boards. She's won numerous awards from various organizations including: the Commission on Ethics, Red Cross, American Society for Public Administration, ACLU, National Council of Jewish Women, League of Women Voters, among others.

Born in New York and raised partly in Latin America, Mayor Levine Cava received her bachelor's degree in psychology with honors from Yale University and graduate degrees in law and social work from Columbia University. She came to South Florida in 1980 to join her husband, Dr. Robert Cava, a Miami native, who returned home to join his father in medical practice. Daniella and Robert raised two children, Eliza and Edward, in Miami-Dade, supported by strong networks of friends, families, and co-workers.

MOST REVEREND THOMAS G. WENSKI

ARCHBISHOP OF MIAMI

Bishop Thomas G. Wenski, born on October 18, 1950, in West Palm Beach, Florida, grew up in Lake Worth and attended Catholic school at his home parish, Sacred Heart. He embarked on his journey in religious service by studying at St. John Vianney Minor Seminary in Miami and later at St. Vincent de Paul Major Seminary in Boynton Beach. He was ordained a priest of the Archdiocese of Miami on May 15, 1976. Throughout his career, Bishop Wenski has exhibited a deep commitment to serving his community and advocating for various causes.

He holds a B.A. Degree in Philosophy (1972) and a Masters of Divinity (1975) from the Boynton Beach Seminary. He furthered his education with a Master of Arts degree from the School of Sociology at Fordham University in New York in 1993. Additionally, he participated in summer courses at the Catholic University of Lublin in Poland.

Bishop Wenski's early pastoral work included serving as an associate pastor at Corpus Christi Church, a predominantly Hispanic parish in Miami. He also played a pivotal role in the establishment of the Haitian Apostolate of the Archdiocese, where he served as associate director and then director of the Pierre Toussaint Haitian Catholic Center in Miami. This center provided essential services, including spiritual guidance, education, legal aid, and social support, to the Haitian immigrant community. Bishop Wenski concurrently served as pastor of several Haitian mission parishes within the Archdiocese.

Throughout the 1980s, Bishop Wenski expanded his outreach efforts to establish Haitian Catholic communities across a wide geographic area, from Homestead to Fort Pierce and even extending to Florida's west coast. He was also known for celebrating the weekly Mass in English for shut-ins at a local ABC affiliate in Miami.

Bishop Wenski's dedication to social service led him to become the Archdiocese Director of Catholic Charities in 1996. He facilitated collaborative efforts between Catholic Charities and Caritas Cuba, the social service arm of the Catholic Church in Cuba, delivering relief aid to various countries including Cuba, Haiti, the Dominican Republic, and Central America.

Appointed as auxiliary Bishop of Miami on June 24, 1997, Bishop Wenski was ordained to the episcopacy on September 3, 1997. He continued to serve within the Archdiocese of Miami, taking on leadership roles in various organizations and committees, including the United States Catholic Conference of Bishops' Committee on Migration and the conference's Committee on International Policy.

In 2003, he was appointed coadjutor bishop of the Diocese of Orlando by Pope John Paul II, assuming the role of the fourth bishop of the Diocese of Orlando on November 13, 2004. During his tenure, he convened the Diocesan Synod, 'Starting Afresh from Christ,' in 2005 and established multiple parishes and missions within the Diocese of Orlando.

Bishop Wenski's linguistic abilities include fluency in English, Haitian Creole, and Spanish. He is known for regularly preaching and celebrating Mass in both languages. He also possesses a limited knowledge of Polish, reflecting his family's heritage.

Throughout his career, Bishop Wenski has shown a deep commitment to his faith, community, and social justice causes. His dedication to serving diverse communities and advocating for vulnerable populations has left a lasting impact in the regions he has served.

FOUNDER, BOARD CHAIR, THE CHILDREN'S MOVEMENT

David Lawrence Jr. is a distinguished figure known for his significant contributions to early childhood development and social advocacy. He retired as the publisher of The Miami Herald in 1999 and shifted his focus to championing children's rights and education.

He chairs The Children's Movement of Florida, an organization dedicated to prioritizing children's welfare in the state. Throughout his career, he has held leadership roles in various initiatives, including the Governor's Children and Youth Cabinet, the Florida Partnership for School Readiness, and successful campaigns for The Children's Trust.

David Lawrence Jr. played a pivotal role in passing a statewide constitutional amendment to provide pre-K education for all 4-year-olds in 2002. He is also known for his involvement in the establishment of the David Lawrence Jr. K-8 Public School and an endowed chair in early childhood studies at the University of Florida.

With an extensive background in journalism, David Lawrence Jr. has received numerous accolades and awards, including honorary doctorates and leadership recognition. He has also been actively involved in community organizations, serving on boards for the Miami Art Museum, United Way, and more.

Together with his wife Roberta, he resides in Coral Gables and has received honors such as "Family of the Year" and "Father of the Year." His impactful work has earned him a reputation as a passionate advocate for children's well-being and education.



REBECCA FISHMAN-LIPSEY

CEO, MIAMI FOUNDATION

Rebecca Fishman Lipsey, president and CEO of Miami Foundation, has significantly grown the foundation since 2020, emphasizing equity and investing over \$100 million into local nonprofits. Prior to her role, she made history as the youngest appointee to the Florida Board of Education and founded Radical Partners, a social impact venture. With over two decades of community involvement, she serves on various Miami-Dade education boards and is an active member of organizations like the Miami Chapter of the International Women's Forum. Metellus is a talk show host, national media commentator, and author, where she discusses issues that impact the Haitian community. Metellus has been recognized with several awards for her leadership and advocacy. An alumna of the Rockefeller Foundation and Harvard Business School program, her motto is "Provide the leadership to get things done!"

Ms. Denis has been very active in her community, founding Avanse Ansanm, an organization that preserves culture and builds economic and political power in South Florida's Haitian-American communities. Ms. Denis is a lover of all people and her life's mission is to dismantle systems of oppression for the liberation of all people.

From Guayaquil, Ecuador, ICE raided her home in 2006, leading to her sister and parents being put through deportation proceedings. Committed to her advocacy, she co-led the "Trail of Dreams" walk from Miami to Washington, DC in 2010, and is credited for spearheading the efforts that led to the DACA program. In 2013, she became the first undocumented Latina to testify before Congress, advocating for immigration reform. She has been recognized for her work numerous times, including Forbes' 30 Under 30, and was celebrated in Elle Magazine. She has a degree in Music Education, Early Childhood Education, and Special Education from Miami Dade College as well as a Doctoral Degree from The New School.



OSCAR LONDOÑO

EXECUTIVE DIRECTOR AT WECOUNT

Oscar Londoño is the Co-Executive Director of WeCount!, a membership-led organization of immigrant workers and families in South Florida, including agricultural workers, construction workers, and domestic workers. He's been actively engaged in various civic and professional organizations, holds an MBA from Nova Southeastern University, and is an alumnus of Harvard University's Kennedy School of Government.
